WE PROVIDE EMERGENCY SHELTER SERVICES FOR APPROXIMATELY 82 BEDS IN LOWER FAIRFIELD COUNTY IN STAMFORD AND DANBURY. BOTH FACILITIES OFFER MEALS AND CASE MANAGEMENT, WITH ADJUNCT SERVICES SUCH AS HEALTH CLINICS, RECOVERY AND YOUNG ADULT SERVICES, OUTREACH, RAPID REHOUSING, AND DIVERSION.

PACIFIC HOUSE PROVIDES SUBSIDIZED AND DEEPLY AFFORDABLE HOUSING WITH CASE MANAGEMENT SERVICES. THIS PAST YEAR WE BROUGHT ON LINE AN ADDITIONAL 40 UNITS OF HOUSING. PRIORITY FOR HOUSING IS GIVEN TO THOSE THAT ARE MOST VULNERABLE, THE CHRONIC HOMELESS.

THIS ALLOWS OUR TENANTS THE ABILITY TO MAXIMIZE THEIR PRIVACY. WE ARE A LEADER IN SHARED HOUSING IN CT. MANY OF OUR BEDROOMS HAVE THEIR OWN BATHROOMS.
